Welcome to the third edition of the PERFORM Randomized Controlled Trial newsletter! The overall objective of the PERFORM trial is to determine the effect of reconstruction on patient-important outcomes compared to internal fixation for the stabilization of an impending or realized pathologic fracture in patients with metastatic bone disease (MBD) of the proximal femur. In this edition, we are excited to provide an update on study initiation, including our **Research Ethics Board Approval!**

RESEARCH ETHICS APPROVAL

We are pleased to announce that we have received research ethics approval from the Hamilton Integrated Research Ethics Board through the Clinical Trials Ontario stream. This approval grants the Methods Centre at McMaster University to proceed as the lead coordinating site for the PERFORM Trial. The approved documents include the Protocol, the Informed Consent Form, and the Case Report Forms.

SITE RECRUITMENT

Our team has invited selected sites to complete a Physician Trial Application (PTA) for the PERFORM Trial. At this time, 6 clinical sites are undergoing the start-up phase which includes local research ethics board/institutional ethics board applications and completing contract negotiations.
